Conditions:

- This agreement is for a period of 12 months from the date written on page 1 of this contract.
- Either party can cancel the agreement at any time.
- If the student cancels the agreement there is a '1 month' exit fee (either \$147 or \$397) charged.
- If the student cancels, any months already coached will be 'back charged' to the applicable full Monthly fee of \$147 or \$397, and any residual monies refunded to the student, eg. If the student (on the Drover package) pays a yearly fee of \$1164.00 and proceeds to be coached for 4 months and then cancels; the refund would be calculated as $\$1164 - 4 * \$147 - \$147(\text{exit fee}) = \429.00 refund. If the refund equates to a minus, the students then owes that figure to IHI.
- The student will be available at the mutually agreed day and time each month.
- If the student will not be available for a coaching call, they need to notify Tony at least 3 days ahead or the Coaching will be charged as if it occurred.
- The student will create and send a video (or the relevant link) to Tony every month, at least 3 days before Coaching date and email Tony to let him know of the video.
- The student will, to the best of their ability, practice the lesson plans agreed to during the Coaching call.
- The student understands they will need to practice their Horsemanship (as per the Coaching Lesson Plan) at least 7 hours per week to achieve their goals.
- If the student sends email questions, and has not received a reply from Tony within 4 days, the student will contact Tony by email and/or phone and follow up.
- * Free course days are available after 12 months continuous coaching.
- * Free course days are only available in courses run at IHI, unless agreed by negotiation with Tony.
